Bids received after this time will not be opened. The bids will be opened and read aloud at the above noted time. All bidders are welcome to attend.

The bids are for a single General Contract for the replacement of athletic field lighting at the Varsity Baseball & Varsity Softball fields. Bids shall be on a lump sum basis; segregated sub-bids will not be accepted.

Work is anticipated to commence following the award of bid and shall be substantially complete on or before April 29, 2022.

A bidder's conference has been scheduled for 11:30 a.m. on November 19, 2021 at ESC (Educational Services Center) College Community School District, 8005 Prairie Spirit Lane Drive SW, Cedar Rapids, IA, 52404. A building/site tour will follow the pre-bid conference.

Plans and specifications governing the construction of the proposed Work have been prepared by Design Engineers, of Cedar Rapids, Iowa.

Bidders for the General Contract may obtain a maximum of 2 copies of the Contract Documents by contacting Rapids Reproductions, Cedar Rapids, IA, Ph. 319-364-2473 in accordance with the Instruction to Bidders upon depositing the sum of \$100 for each set of printed documents. A free download is available at www.rapidsrepro.com. A non-refundable mailing and handling fee of \$25 per set (written as a separate check) will be charged for each document requested to be mailed. Other sub-bidders may obtain 1 set of documents for a period of four working days on the deposit basis mentioned above. Bidding Documents will be available after November 12, 2021.

Any bidder, upon returning the documents in good condition and in accordance with the Instruction to Bidders, shall be returned the deposit in full. Any bidder failing to comply with the Instruction to Bidders will forfeit deposits.
