Additional Open Enrollment Program Considerations and Closures:

All Open Enrollment requests will be filled on a first come, first served basis until each capacity level for open grades and programs are met.

Open Enrollment Allowance can be discontinued or modified at any time due to enrollment trends; however, applications Board approved prior to any changes will be honored.

The following program considerations are determined annually by the school board:

Special Education

- Open enrollment applications for students requiring special education services may be denied if the current and projected roster exceeds capacity as determined by the District Developed Service Delivery Plan or if the District does not offer an appropriate educational program for the student as defined by IDEA. The level 1 programs district-wide have increased enrollment of 17 students. The level 3 programs district-wide have increased enrollment of 36 students, which is significant given the amount of supports and services we provide based on the individual student needs. The increase in weighted enrollment is starting to stress our teacher roster size. We have teacher roster sizes across the district that have reached well beyond what is considered a full roster of 50 points as determined by the Caseload Determination Worksheet in the District Developed Service Delivery Plan. This is reducing the capacity of the teacher to provide high levels of individualized instruction. The current special education deficit continues to increase as the district provides the necessary resources for resident students. The FY20 deficit was \$1,750,756 million. The FY22 education deficit was \$2,072,050 million.
- Currently, 84 of 648 students (14%) with IEPs are open enrolled due to continuation of services provision in the OE law. Of those 84 OE students, (42%) require additional services based on the weighting of level 2 or level 3 on the IEP.
- There is a shortage of teachers certified to teach in special education programs. This shortage has caused the district to begin the academic year with unfilled positions or to hire teachers who are not certified to teach special education and must pursue an Executive Director Decision license and complete required coursework. There are currently 4 unfilled teaching positions posted for special education. We were unable to fill 3 Strat II LD/BD positions and 1 Strat II ID position. This shortage also extends to paraprofessional positions. There are currently 17 unfilled paraprofessional positions across the district. These positions are difficult to fill and retaining staff is challenging.

Other Specialized Programs

- When the percentage of students requiring at-risk programming support exceeds 5% in a given grade level, open enrollment applications may be denied.
- English Language Learning populations have grown by 53% over the past 5 years, from 180 in the 2018-2019 school year to 290 active students currently this school year (as of 2/8/2023). Funds to support programming for resident ELL students far exceeds monies allotted through weighted enrollment. Applications for students requiring EL programming at certain grade levels may be denied.
- Note: the factors above indicate likelihood of most programs being closed to OE due to insufficient classroom space

Other Annual Considerations

- When any grade level exceeds target enrollment, applications may be denied.
- If New Open Enrollment Opens:
 - Applications will be processed in order of receipt
 - Sibling guarantee for first year may be limited, in subsequent years, sibling enrollment will not be guaranteed in accordance with Board Policy
 - Transportation will not be provided
 - Open Enrollment is being utilized as a financial tool to ensure continued programming after the financial impacts of the pandemic. While 22-23 is the second year of being open after two decades of being closed, It is not anticipated that Open Enrollment will continue in future years as we predict the actual enrollment will align more closely with projected enrollment.
